**[REDACTED] ORDER APPROVING DISTRIBUTION
OF THE RESERVE FUND**

After review of Plaintiffs' Motion for an Order Authorizing Disposition of the Reserve Fund ("Reserve Distribution Motion"), the Memorandum in support thereof, and the entire record in this matter, IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. The procedures used and actions taken by Claims Administrator Kurtzman Carson Consultants ("KCC") and Plaintiffs' Class Counsel for the administration of the Settlements and initial distribution of the settlement funds are hereby adjudged to have been proper and complete, and the administrative determinations of KCC in accepting and rejecting late Claims filed in this matter are approved.
2. The properly documented reserve fund Claims listed in Exhibit B to the Affidavit of Derek Smith ("Smith Affidavit"), submitted as Exhibit 1 to Plaintiffs' Reserve Distribution Motion, for previously Authorized Claimants with Claims worth more than \$250 that cashed their initial distribution checks are approved. These Claims are henceforth referred to as the Authorized Reserve Fund Claimants.
3. The recommendation by KCC to accept the claims listed in Exhibit C to the Smith Affidavit that were not included in the initial distribution but were the subject of compelling circumstances, as required by Paragraph 5 of the Order Approving Distribution of the Remaining

Settlement Funds, dated November 13, 2019 (the “Initial Distribution Order”), is approved and those claims are accepted. These Claims are henceforth referred to as the Authorized Late Claimants.

4. KCC is directed to distribute the reserve portion of the Net Settlement Fund to the Authorized Reserve Fund Claimants and Authorized Late Claimants as delineated on Exhibits B and C of the Smith Affidavit, in accordance with the Plan of Distribution, and each Authorized Reserve Fund Claimant or Late Claimant shall receive his/her/its share of the Net Settlement Fund calculated by KCC, based on their calculated recognized Claims, after subtracting any payment he/she/it received as part of the Initial Distribution.

5. No additional fees or expenses are to be paid from the reserve portion of the Net Settlement Fund in connection with this Second Distribution.

6. Checks for distribution to the Authorized Reserve Fund Claimants and Late Claimants shall bear the notation “Non-Negotiable After 90 Days” and no check shall be negotiated from the settlement funds more than 90 days after the date of the check. Any checks that are reissued at the request of the claimant shall bear the notation “Non-Negotiable After 30 Days” and no reissued check shall be negotiated from the settlement funds more than 30 days after the date of the check.

7. One year after this distribution of the reserve portion of the Net Settlement Fund to Authorized Reserve Fund Claimants and Authorized Late Claimants, KCC may destroy all claim forms and related correspondence. However, KCC shall retain all administrative records, including its copy of the Claimants Listing and its computer database and programs used to create the Claimants Listing, for a period of three (3) years after this distribution of the reserve portion of the Net Settlement Fund to Authorized Reserve Fund Claimants and Authorized Late Claimants.

DECLARATION OF DEREK SMITH

RE: DISTRIBUTION OF THE NET SETTLEMENT FUND RESERVE

I, Derek Smith, declare that:

1. I submit this Declaration in order to provide the parties and the Court with information regarding the Initial Distribution and the proposed Second Distribution.
2. I am a Director of Class Action Services at KCC Class Action Services LLC (“KCC”), located at 3301 Kerner Boulevard, San Rafael, CA 94901. I am over 21 years of age and am not a party to this action. I have personal knowledge of the facts set forth herein and, if called as a witness, could and would testify competently thereto.

Initial Distribution

3. On December 5, 2019, KCC caused the Initial Distribution of 1,315 checks, totaling \$20,926,633.19, to be issued to the Authorized Claimants. The Initial Distribution included a) 1,106 Authorized Claimants that were issued approximately 90% of their estimated share of the settlement funds, and b) 209 Authorized Claimants that were issued a one-time \$250 payment.

To date, 1,301 of the 1,315 (98.94%) Authorized Claimants have deposited their checks, worth a combined value of \$20,900,724.09. That total includes 1,096 of the 1,106 (99.10%) Authorized Claimants that received 90% payments (“Authorized Reserve Fund Claimants”) and 205 of the 209 (98.09%) Authorized Claimants that were sent one-time \$250 payments. The amount of \$25,909.10 currently remains uncashed.

4. KCC has also received 7 late claims submitted with compelling circumstances. The claims were submitted late because of inaction on the part of a designated third-party filer, and not due to inaction on the part of these late claimants. KCC recommends the full value payment of these 7 late claims be made directly to the 7 claimants (the “Authorized Late Claimants”) as part of the Second Distribution, which payments represent 100% of the pro rata shares each would have received had they timely filed claims.

Second Distribution

5. The Net Settlement Fund has a reserve of \$2,326,500.80. Combined with the uncashed check amount of \$25,909.10, there is \$2,352,409.90 available for the Second Distribution (the “Reserve Fund”).¹ KCC recommends that the 1,096 Authorized Reserve Fund Claimants and the 7 Authorized Late Claimants, a total of 1,103 Authorized Second Distribution Claimants, be paid according to Exhibit A. A true and correct copy of Exhibit A is attached hereto. A true and correct list of the 1,096 Authorized Reserve Fund Claimants is attached hereto as Exhibit B. A true and correct list of the 7 Authorized Late Claimants is attached hereto as Exhibit C. As a result of the acceptance of these 7 late claims, the Authorized Reserve Fund Claimants will have

¹ The size of the Reserve Fund may increase due to a potential tax refund of approximately \$33,000 that is presently pending. Though the refund is not expected to be substantial in relative terms, to the extent it does increase the size of the Reserve Fund, there will be a *pro rata* increase to the proposed Second Distribution amount for each Authorized Reserve Fund and Authorized Late Claimant. As a result, the Proposed Second Distribution amounts specified in Exhibits A-C are estimates, though they are unlikely to change substantially.

received 91.37% of their total distribution during the Initial Distribution and the remaining 8.63% of their total distribution during the Second Distribution.

6. Upon approval of the Court, KCC will promptly mail all Authorized Second Distribution Claimants their approved shares of the funds.

7. KCC's conclusions regarding the sufficiency and *pro rata* calculation of class claims reflect KCC's independent judgment and were not improperly influenced by any of the parties' legal counsel to this action or any other outside person or entity.

8. The administration of claims in this matter was performed in a manner consistent with the process of other direct purchaser antitrust actions in which KCC has been involved.
